Seeking firms with expertise in providing mobile medical services in Ukraine

Corus leads an ensemble of social impact organizations working together in the world's most fragile settings to deliver the holistic, lasting solutions needed to overcome the interconnected challenges of poverty, health care access and climate change.

Corus has been working in Ukraine since the beginning of the war in 2022 and implements a series of programs ranging from supporting the displaced, vulnerable population in mobile health service access, agriculture, and livelihood restoration to winterization and other humanitarian needs.

Anticipated Services:

Corus International is applying for a 12-month humanitarian program that includes the provision of mobile medical services to vulnerable populations, including Internally Displaced Persons (IDPs),

returnees, and other vulnerable groups. The project geography anticipates the provision of these services across select districts of Chernihiv, Sumy, Kharkiv, and Zaporyzhzhya regions, and often covering high-risk Hromadas affected by the ongoing conflict. Mobile Medical Services are expected to be carried out using modified mini-buses or equivalent transportation, which will serve as temporary medical check-up offices for the doctor's brigade accompanying the vehicle.

In general, medical services revolve around primary care and referrals, and include specialists such as family doctors (with a specialty in Cardiology), Psychologists, and Gynecologists. As part of the medical services, the mobile team should have access to, or be able to travel with, a psychologist who will provide emergency psychological support and mental health and psychosocial services to the affected population.

The provider will be working closely with Corus International's team as it relates to the planning of the movement, patient management, safety and security, access and other pertinent logistics associated with the delivery of services. Illustrative services include:

- General patient intake
- Gynecological evaluation (including rapid screening tests)
- ECG and portable ultrasound capabilities, Holter monitoring
- Access to and ability to input patient data into the centralized national database "ESOZ"
- Psychological support / Trauma care
- It is anticipated that the project will cover 10,000 patients across the proposed geographies, and the provider will be advised on the estimated number of beneficiaries split per region.

Selection criteria for interested parties We invite entities to apply to pre-qualify in this EOI, including but not limited to institutions and NGOs. The following criteria must be met to prequalify under this EOI, and respondents should clearly identify and nominate such sources and evidence to substantiate their qualification. The entity must:

1. Be legally registered to work in the country.
2. Have an active medical license to provide health services as described above.
3. Demonstrate that it has the staff and/or established networks to assemble and manage a team of health service providers (doctor's, nurses and other support staff) necessary to deliver the work.
4. The capacity to negotiate and seek approvals from the regional (and / or other) Departments of Health enabling their operations within the coverage areas.
5. Demonstrated past performance of mobile medical services provided in one or more targeted regions at scale.
6. Past experience of working with international organizations is preferred.

Procedure to submit expressions of interest:

Interested parties should prepare a package, to include the following information:

- Company/Individual profile and legal status.

- Services provided, including, but not limited to, the list of proposed services specified above, as well as the estimated cost structure overview for providing such services (e.g., the cost of providing comprehensive medical coverage for one patient (broken down by category of medical services) for a specific region or area of provision).
The more detailed and final scope of services, along with their breakdown by region, will be agreed upon during negotiations of the service contract.
- Documentary evidence (references, cooperation agreements, service contracts) of previous experience in providing relevant mobile medical services as part of the humanitarian response in two or more of the following regions: Sumy, Zaporyzhzhia, Chernihiv, and Kharkiv.
- Profile and qualifications of experts completing the services, corporate structure of the organization.
- Medical licenses and documents confirming the qualifications of personnel providing medical services (diplomas, certificates, etc.)
